# **Alma Primary School Privacy Notice**

You have a legal right to be informed about how our school uses any personal information that we hold about you. To comply with this we provide a 'privacy notice' to you where we are processing your personal data

# This Privacy Notice explains how we collect store and use your personal data about you.

We collect information about:

- pupils of our school, including prospective pupils
- people that have responsibility for our pupils (such as parents, carers etc.)
- our staff and volunteers, the school's workforce

This information is used to help us:

- deliver education
- contact the right people about issues
- ensure a healthy, safe environment for learning
- carry out our functions as an employer

If we hold data about you, you have rights in respect of your data including:

- the right to be supplied information on our uses
- to see what data we are holding about you
- to request correction or erasure of your data
- to object to processing
- to complain to our data protection officer or the supervisory authority

# **Data Usage Regarding Pupils**

### The categories of information that we collect, hold and share include:

- Personal information (such as name, unique pupil number and address)
- Characteristics (such as ethnicity, language, nationality, country of birth and free school meal eligibility)
- Attendance information (such as sessions attended, number of absences and absence reasons)
- Admissions information including waiting lists
- Educational information (such as lesson plans, test/exam results, learning challenges, school reports, EYFS profiles)
- Health information and medical records (such as illnesses that may affect pupil safety in school e.g. allergies, asthma, epilepsy, dietry requirements)
- Accident reports and risk assessments
- Safeguarding information
- Social services reports and records (where appropriate)
- SEN information
- Details of any behaviour issues or exclusions
- Photographs
- Videos
- CCTV images

### Why we collect and use this information

We use the pupil data:

- to support pupil learning
- to monitor and report on pupil progress
- to provide appropriate pastoral care to look after our pupils well-being
- to assess the quality of our services
- to comply with the law about data sharing
- to get in touch with parents/carers when we need to
- to track how well the school as a whole is performing

### The lawful basis on which we use this information

We collect and use pupil information under:

- We need to comply with the law
- the GDPR Article 6 (c) for example where we are required to do so by the Education Act 1996
- the GDPR Article 6 (d) and 9 (c) for example critical health information about pupils that may put them at risk

 the GDPR Article 6 (a) – for example where data has been supplied by the parent for use in the school setting e.g. information about family preferences in respect of religion

Full details of the legal basis for our data use is given in our Data Protection Impact Assessments which are available on request.

Note that Health professionals commonly gather data in school settings for a variety of purposes. This data is **not** held by the school, and is detailed in the Local Authority privacy notice at <a href="https://new.enfield.gov.uk/privacy-notice">https://new.enfield.gov.uk/privacy-notice</a>.

# **Collecting pupil information**

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to give certain information to us or if you have a choice in this.

### Storing pupil data

We will keep personal information about you while you are a pupil at our school. We may also keep it after you have left the school, where we are required to by law.

We store pupil data as detailed in our retention schedule, which can be found on our school website.

### Who we share information with

We routinely share pupil information with:

- schools that the pupil will attend after leaving us
- our local authority
- the Department for Education (DfE)
- NHS staff working in the school setting
- Ofsted
- Suppliers and service providers so that they can provide the services we have contracted them for eg photographers, music lessons
- Health and social welfare organisations
- Professional advisors and consultants
- Police forces, courts and tribunals

# Why we share pupil information

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

We are required to share information about our pupils with our local authority (LA) and the Department for Education (DfE) under section 3 of The Education (Information about individual pupils) (England) Regulations 2013.

### **Data collection requirements:**

### The National Pupil Database (NPD)

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

- conducting research or analysis
- producing statistics
- providing information, advice or guidance

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

- CCTV images captured at school
- Photographs
- Videos
- InVentry system

### Why we collect and use this information

We use the data about people that have responsibility for our pupils:

- to contact them, both routinely and in emergencies
- to ensure they are kept aware of pupil's progress as appropriate
- to comply with the law regarding data sharing
- to provide appropriate pastoral care
- protect pupil welfare
- to record events and celebrations at the school
- to comply with health and safety and safeguarding requirements

### The lawful basis on which we use this information

We collect and use this information under:

- the GDPR Article 6 (c) for example where we are required to do so by the Education Act 1996
- the GDPR Article 6 (a) for example additional contact information supplied to us above that required by law
- to comply with the law

Full details of the legal basis for our data use is given in our Data Protection Impact Assessments which are available on request.

# **Data Usage Regarding Schools Workforce**

# The categories of school workforce information that we collect, process, hold and share include:

- personal information (such as name, employee or teacher number, national insurance number)
- special categories of data including characteristics information such as gender, age, ethnic group, vetting and barring information
- contract information (such as start dates, hours worked, post, roles and salary information)
- work absence information (such as number of absences, reasonsand medical certificates)
- qualifications (and, where relevant, subjects taught)
- training and performance management information/appraisals
- recruitment information, including copies of right to work documentation, references and other information included in the application process
- bank account details, payroll records and tax status information
- outcomes of any disciplinary and or grievance procedures
- safeguarding information
- copy of driving license if used for DBS identity check or if claiming mileage or transporting pupils
- photographs
- videos
- CCTV footage
- · vehicle details
- · occupational health reports
- risk assessments where needed
- health and safety assessments and accident records

# Why we collect and use this information

We use school workforce data to:

- enable the development of a comprehensive picture of the workforce and how it is deployed
- inform the development of recruitment and retention policies

- maintain safety of staff and pupils
- facilitate safe recruitment, as part of our safeguarding obligations towards pupils
- enable individuals to be paid
- effective performance management
- monitor gender pay gap
- improve the management of workforce data across the Academy
- to record events and celebrations at school

### The lawful basis on which we process this information

We process this information under GDPR Article 6 (b) the employment contract and Article 6 (c) e.g. Education Act 1996. Certain special characteristics are processed under GDPR Article 6 (c) and Article 9 (b) e.g. Ethnicity information required by the Equalities Act 2010.

- Fulfil a contract we have entered into with you
- Comply with a legal obligation

### **Collecting this information**

Whilst much of information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with data protection legislation, we will inform you whether you are required to provide certain school workforce information to us or if you have a choice in this.

# **Storing this information**

We store data as detailed in our retention schedule, which can be found on our school website.

### Who we share this information with

We routinely share this information with:

- our local authority
- the Department for Education (DfE)
- Ofsted (when applicable)
- suppliers and services provides to enable them to pride the service we have contracted them form such as personnel and payroll
- auditors (when applicable)

### Why we share school workforce information

We do not share information about workforce members with anyone without consent unless the law and our policies allow us to do so.

### Local authority

We are required to share information about our workforce members with our local authority (LA) under section 5 of the Education (Supply of Information about the School Workforce) (England) Regulations 2007 and amendments.

### **Department for Education (DfE)**

We share personal data with the Department for Education (DfE) on a statutory basis. This data sharing underpins workforce policy monitoring, evaluation, and links to school funding / expenditure and the assessment educational attainment.

We are required to share information about our school employees with our local authority (LA) and the Department for Education (DfE) under section 5 of the Education (Supply of Information about the School Workforce) (England) Regulations 2007 and amendments.

### **Data collection requirements**

The DfE collects and processes personal data relating to those employed by schools (including Multi Academy Trusts) and local authorities that work in state funded schools (including all maintained schools, all academies and free schools and all special schools including Pupil Referral Units and Alternative Provision). All state funded schools are required to make a census submission because it is a statutory return under sections 113 and 114 of the Education Act 2005
